

Protecting your private information is our priority. This Statement of Privacy applies to www.iprepped.com and I Prepped, LLC and governs data collection and usage. WHAT PERSONAL INFORMATION WE COLLECT AND HOW WE DO IT

We collect data in two ways, information you provide to us and data that is automatically gathered when you visit our Site.

Information provided by you:

SECURITY OF YOUR PERSONAL INFORMATION

This includes our hosting platform and our payment processing platform. I Prepped, LLC does not store any payment information, nor do we have access to this data.

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. SHARING INFORMATION WITH THIRD PARTIES

I Prepped, LLC does not sell, rent, or lease its customer lists to third parties.

TRACKING USER BEHAVIOR

I Prepped, LLC may keep track of the websites and pages our users visit within I Prepped, LLC in order to determine which I Prepped, LLC services are the most popular. E-MAIL COMMUNICATIONS

EXTERNAL DATA STORAGE SITES

Your information, including personal data, may be transferred and maintained on servers outside of your state, province, country, or other government jurisdiction where data protection laws may differ from your jurisdiction. If you are located outside the United States, we may transfer your personal data to the United States and process it there.

SITE ANALYTICS

We use Google Analytics to help us analyze the traffic to our website using cookies and other similar technologies. In accordance with GDPR regulations, before collecting personal information about a site visitor's actions, we ask for permission to install first and third-party cookies.

A visitor's decision to accept or deny cookies from our site will be retained for a period of 12 months. Users can use the cookie preferences link (found in the bottom, right corner of every webpage) to modify their cookie settings before the end of the 12-month period. At the end of one year, visitors will be required to refresh their cookie options once again.

DO NOT TRACK

LEGAL BASIS TO PROCESS DATA

Only when we have a legal basis for doing so under Article 6 of the GDPR do we collect and handle user data for those who are residents or citizens of the EU.
